- \*Follow freeway signs out of airport to I-5 North (Towards Seattle) \*Take I-5 North

- \*Go to Wallingford and turn left, go to No. 34th & turn left
- \*Go two blocks to Meridian. Consumer Opinion Services will be in the building on your right.

- \*Take the Vancouver B.C. I-5 Northbound exit. Stay in right lane when you get on I-5.
- \*Take N.E. 45th St. exit off I-5.
- \*At stop light turn left onto N.E. 45th.
- \*Go to Wallingford and turn left, go to No. 34th & turn left.
- \*Go two blocks to Meridian. Consumer Opinion Services will be in the building on your right.
